Subject: Rollout of EOS Platform Version 3.5

Pursuant to the circulars published in respect of EOS Platform upgrade and Notice No. TECH-2018-006 dated February 06, 2018, Members are requested to note the scheduled implementation of EOS Version 3.5 on production environment as stated below.

EOS Version 3.5 will be live from the start of Trading Day Friday, March 16, 2018.

Members are requested to download and install EOS-Trader application from the FTP Server to access the upgraded trading platform. The details of the FTP Server and download procedure are provided in attached Annexure. EOS-Clear Users would need to reset their window using 'Reset Perspective' tab after login. Please note that the new EOS-Trader and EOS-Clear applications are not backward compatible.

EOS Trader application will be available for download from Friday, March 9, 2018.

Members and Vendors using PORTS for trading on EOS Platform, subscribing market data feed via EMAPI (MBL or POBE), accessing Drop Copy and Back Office files are required to upgrade their respective application/systems to be compatible with EOS Version 3.5 before the start of trading on Friday, March 16, 2018. There will be no change on User's login credential, Gateway IPs and access Ports.

All Good Till Cancel (GTC) and Good Till Date (GTD) orders shall be cancelled at END of day on Thursday, March 15, 2018 and shall NOT be active on Friday, March 16, 2018.

To support smooth transition, historical data availability in EOS Platform will be reduced to 7 days from current 30 days with effect from Friday, March 09, 2018.

Installation Basics

EOS-Trader

- Login to FTP Server and download the EOS-Trader exe file based on the operating system (32 bit or 64 bit).
- Run the file EOS-Trader-3.5-x32.exe or EOS-Trader-3.5-x64.exe and use the password **eos3.5** to extract & install the file.
- Extract the application in the local directory without changing the folder name.
- Upon successful installation, it will create a separate shortcut on the desktop named **EOS-Trader-3.5-x32** or **EOS-Trader-3.5-x64** depending upon the exe installed.
- EOS-Trader users can access upgraded EOS Trading Platform via existing F5 SSL VPN (Internet) or using the Local/Global MPLS/P2P link which are already in place
- The SSL VPN Client software can also be downloaded from the above FTP Server, if required.
- The login credential for the EOS Trader and VPN will remain same as existing production (Live) access.

EOS-Clear

- EOS-Clear is a web based application and therefore no separate upgrade is required.
- Users need to reset the perspective on EOS-Clear after login to access the full functionality. Go to **Window** and **Reset Perspective**.
- EOS-Clear can be accessed via the existing F5 SSL VPN or Local/Global MPLS/P2P link.
- The URL link to access EOS-Clear along with login credential will remain same as existing production (Live) environment. <http://clear.dgcx.ae:8082/dgcx/Dgcx.html>

PORTS (FIX) / Drop Copy and EAPI Users

- FIX/ Drop Copy and EAPI Gateways can be accessed by the Members either via IPSec tunnel (Internet) or on the existing Local/Global MPLS/P2P link or Colocation Servers which are used as on date.
- **Applications which are not recompiled for Version 3.5, shall not be able to login and obtain data from the upgraded EAPI Gateways.**
- **Please complete the conformance test before go-live date.**

COMMON SUPPORT DOCUMENTS

- All documents related to EOS technology platform upgrade along with help files and back-office formats including the ones which were shared earlier can be found in **Common** folder on the FTP Server. <ftp://eosftp.dgcx.ae/Common>

LOGIN PROCEDURE

- There is no change in the login procedure. Members should use their existing Live User ID and corresponding passwords to log-in for the new version of EOS-Trader/ EOS-Clear/ EAPI and FIX Gateways.
