Subject: Fees and Charges for 2020

Pursuant to DGCX By-Laws, and the Clearing Rules of the DCCC, Members are advised that the Fees and Charges for 2020 have been published today, and which will take effect on and from **1** January **2020**.

The following changes should be noted:

Annual Membership Fees

The annual membership fee structure has been amended to reflect the changes in membership categories that were introduced in May 2019, alongside the implementation of the DCCC Default Fund. In addition, it has been determined that there should be a further differentiation between membership of DGCX and membership of DCCC. Therefore, the annual membership fees for 2020 shall be as follows:

Inactive/Deactivated Members – Any DGCX Member who has not been activated for live trading whether mapped or not to a Clearing Member as at 1 January 2020.

Active Members will have the annual membership fees collected through their respective Clearing Member's settlement account in the first week of January 2020. The applicable fees will reflect in the Clearing Member's Daily Obligation Statement, together with details of the fees charged.

Inactive Members are required to pay the annual membership fees via telegraphic transfer (TT), and details of the relevant payment instructions can be found in Appendix I. It should be noted that an additional charge of USD 50 will be levied to cover TT remittance charges.

For locally registered Members under inactive/deactivated status, who wish to pay the Annual Fees in UAE dirhams should use the exchange rate published by the Central Bank of the UAE at the time of making the payment and are required to submit a cheque favoring the "Dubai Gold and Commodities Exchange DMCC" for the equivalent amount.

Inactive/deactivated Members must pay the annual membership fees by no later than 31 January 2020. Non-payment of the annual membership fees by the due date will result in termination of membership.

Trading Fees

- 1. Indian Rupee Quanto Futures Contract (DINRI): \$0.06 per lot (was previously \$0.04 per lot).
- 2. Indian Gold Quanto Futures Contract (DIG): \$0.55 per lot (was previously \$0.35 per lot)
- 3. Shari'ah Compliant DGCX Spot Gold Contract (DGSG): \$13 per lot (was previously \$1.5 per lot).

All other trading fees remain unchanged.

Clearing Fees

- 1. All products that were previously \$0.10 per lot will be charged at a rate of \$0.14 per lot.
- 2. Mini USD/INR Futures Contract (INRM): \$0.04 per lot (was previously \$0.03 per lot).
- 3. Shari'ah Compliant DGCX Spot Gold Contract (DGSG): \$2 per lot (was previously \$0.30 per lot).

All other clearing fees remain unchanged.

Settlement and Delivery Fees

- 1. All other products other than those below: \$0.15 per lot.
- 2. AUD/USD Futures Contract (DAUD), CAD/USD Futures Contract (DCAD), CHF/USD Futures Contract (DCHF), EUR/USD Futures Contract (DEUR), GBP/USD Futures Contract (DGBP), JPY/USD Futures Contract (DJPY),: \$0.25 per lot.

- 5. Shari'ah Compliant DGCX Spot Gold Contract (DGSG): \$5 per lot.

User Access Charges

Additional EOS-Trader ID: \$15 per ID per month.

Additional EOS-FIX ID: \$35 per ID per month.

Additional EOS Admin ID: \$125 per ID per month.

Additional EOS Drop Copy ID: \$250 per ID per month.

POBE ID: \$200 per ID per month.

Members will continue to be eligible for up to 6 EOS Admin IDs (up to 3 CM and 3 TM User IDs); 3 EOS-Trader IDs; 3 EOS-FIX IDs; 1 EOS Drop Copy ID; and 1 EMAPI ID free of charge.

5% VAT will apply to all fees for applicants/Members domiciled within the UAE but will **NOT** apply for applicants/Members domiciled outside the UAE.
