Subject: Amendment to the Settlement Currency of DGCX Chinese Yuan Futures Cash Settled Contracts

In pursuance of the By-Laws of DGCX, and the Clearing Rules of DCCC, and Notice No.TRDG-2015-034 dated November 30, 2015 the following is hereby notified:

The Exchange shall amend the settlement currency of cash settled Chinese Yuan Futures Contract effective Tuesday, March 14, 2017.

In view of the above and in order to ensure smooth transition, the Exchange shall temporarily suspend all cash settled Chinese Yuan Futures Contract without any Open Interest with immediate effect and update the Last Day of Trading for DUSDCNH-20170330 Contract to **Monday, March 13, 2017** and re-activate Chinese Yuan Futures Cash Settled Contracts with amended Contract specifications effective **Tuesday, March 14, 2017**.

Annexure 2 provides for the Contract Calendar of the Chinese Yuan Futures Contracts without any open Interest to be temporarily suspended with immediate effect.
