The Exchange shall list additional delivery months, Calendar Spreads and amend the "Cash Settlement Day" of the WTI Sweet Crude Oil Futures Contracts and Brent Crude Oil Futures Contracts effective **Friday**, **July 14**, **2017**. Accordingly, Members will have Month 1 (M1) to Month 18 (M18) Delivery Months available for trading.

Additionally, the Exchange will also list Calendar Spread contracts for cash settled WTI Light Sweet Crude Oil Futures Contracts and Brent Crude Oil Futures Contracts on the above delivery months in a phased manner as below

- (A) 36 Calendar Spreads between M1-M9 will be available for trading from Friday, July 14, 2017
- (B) 30 Calendar Spreads between M10-M12 will be available for trading from Friday, July 28, 2017
- (C) 87 Calendar Spreads between M13-M18 will be available for trading from Friday, August 04, 2017
