Sub.: Changes in Margins on Silver Futures Contracts

In pursuance of By-laws of DGCX, Clearing rules of DCCC and in terms of notices no. TRDG-2008-006 dated March 3, 2008 the following changes are hereby notified:

Changes in Margins on Silver Contracts

- Minimum Initial Margin on all Silver futures contracts shall be revised to US\$ 1,250 per contract
- 2. **Delivery Period Margin** on all Silver futures contracts shall be levied at US\$ 6,250 per contract. It shall be applicable during the last six trading days for all open long or short positions that have not been liquidated.

These changes shall be applicable immediately.
